At the Federal level The administration's vantage plans. actions could have devastating effects on seniors' pensions, access to medical care and nursing homes. Proposed elimination of Federal education aid to public schools would increase local school taxes, result in major program cuts and increase pressure to cut retire ee benefits such as health insurance.

We oppose the new administration, with support from congressional majorities, pledging to:

- eliminate the Department of Education and Federal aid to schools, which now funds 14% of the average public school's budgets.
- cut \$2 trillion in Federal spending out of a \$7 trillion dollar annual budget. (Washington Post)
- be open to eliminating vaccine mandates

and Federally funded vaccine programs (NBC News)

- cut or eliminate payroll and Social Security benefit taxes
- cutting and caping Medicaid spending, which is the primary funding mechanism for most nursing home resident care for seniors and the disabled, converting it to block grants to states. (KFF)

Federal Advocacy will:

- Support the Social Security Expansion Act to ensure long term financial security for Social Security and Medicare.
- Support legislation to protect, preserve and strengthen Medicaid.
- Support elimination of Social Security benefit taxes only if it is not paid for by the Social Security trust fund to prevent expediting of the depletion of the trust fund.

Oppose all cuts to Federal aid to education and the proposed elimination of the Department of Education.

State Advocacy will continue to:

- work to pass the Health Equity For Retirees Act preserve retiree health insurance benefits and prevent any reductions in benefits or mandates to switch to Medicare Advantage plans.
- work toward further reform to Tiers 5 & 6 to enable districts to attract more prospective teachers to the profession.
- advocate for the state to help pick up the difference for the imminent loss of Federal education aid to school districts.

Advocate for an increase in the base for computing pension cost of living which would greatly help our most elderly members.

Health Insurance: K. Mulligan

The content of this article is, in part, from The Coffee Hour meeting of March 6, 2025 and The CEWW Consortium Health Advisory Board meeting I attended in February, 2025. Some very good news was shared at the Cof- Member Profiles: Cindi Lafountain fee Hour that can only be perceived as an additional benefit. Guardian Nurses is a nationwide organization that was recently contracted to provide advocacy for Consortium members in dealing with the "red tape" and confusion of healthcare in the North Country. Two nurses will be hired by Guardian Nurses to assist and guide members, as needed, in Clinton and Essex Counties. Nationally this service has become increasingly important, especially in rural environments. This new service is expected to begin in April or May, 2025. The Health Insurance Consortium website at cewwhealth.org will provide the latest updates on this new program.

frequently raised topic "Pre-A is Authorization Decisions". Our Consortium health insurance plans generally follow the Pre-Authorization procedures and decisions of Medicare. Pre-Authorization forms. needed, can be found on the Anthem Portal or the Sydney App. (menu My Plan).

Today, for Platinum Plan 1 a family plan will cost \$46,000/yr. beginning July 1, 2025. For Platinum Plan 2, a family plan will cost \$35,813/yr. For many of us on Medicare, Plat- keep her active. inum Plan 1 will cost \$11,931/yr. beginning July 1, 2025. Medicare Primary on Platinum Plan 2 will cost \$10,669/yr. beginning July 1,

2025. Most of these costs are being incurred by our area school districts for both active as well as retired employees. Depending on local contracts, a fraction of these expenses may be incurred by the employee and/or retiree. It behooves all of us to be supportive of our area school districts, especially during budget time. Our health insurance is truly a GIFT to APPRECIATE.
